I. INFORMATION WE COLLECT

We collect “Non-Personal Information” and “Personal Information.” **Non-Personal Information** includes information that cannot be used to personally identify you, such as anonymous usage data, general demographic information we may collect, referring/exit pages and URLs, platform types, preferences you submit and preferences that are generated based on the data you submit and number of clicks. **Personal Information** includes your email, name, address, payment information, health issues, and relationship details. The information that we collect will be used to contact or identify you which you submit to us through the registration process at the Site.

Information collected via Technology:

To activate the Service you do not need to submit any Personal Information other than your email address. Personal Information:
